Parallel Project Management Limited are registered with the Information Commissioners Office to process personal data and during our business relationship with you we will need to collect some of your personal data or where you are a business client, that of your employees. We have a statutory duty to handle this data in a responsible manner according to the relevant regulations.

The type of data we collect and from where includes

Use of Your Information

The information that we collect and store relating to you is primarily used to enable us to provide our services to you. Specifically, we may use the information for the following purposes:

- Sharing with our selected partners and suppliers to enable us to be able to fulfil our contract with you and to provide the services you have purchased. This may entail sharing information across our paper and electronic systems (such as web site, accounting system, email, etc)
- We make course registrations, exam bookings, booking courses, venue bookings, delivering material and generally keeping in contact with you
- We maintain your exam results on our systems to calculate our business performance measures
- We may share your information with credit reference agencies and other companies for use in credit decisions, for fraud prevention and to pursue debtors
- Where we collect data about your web site visit we may utilise cookies to improve our service to you and to understand your interaction with our site. Storing Your Personal Data

- Dietary requirements to our supplier(s) as necessary
